Council Member Linnie Richardson stated that they had an issue with a commercial business owner in the town of Pierson clearing trees and the land on Sunday and digging in a retention pond. Mayor Gray Leonhard stated that he went to property and told them to stop working and at that time noticed that the tractor was in the pond. Then he noticed that on the property that the tractor was in the pond. Town Planner Mark Karet explained that he needs a site plan if he is planning on removing a bunch of stuff. Mayor Leonhard continued that they are not using the tractor to grab. Council Member Linnie Richardson asked if he could be fined or have restore the trees that were removed. Town Planner Mark Karet stated that per land development code and the site plan approval they will have to plant new trees. Town Planner Mark Karet stated that he will need to get an arborist report to proceed with the four water oaks. Vice Mayor and Council Member Jimmy Anderson state water oaks root systems go out and not down and blow over in the wind when they get hollow it's over. Now the live oak will live forever. Resident Denise Colflesh asked if we have a arborist in town? Mayor Gray Leonhard responded that he does not think we do. Property owner Chris Wilcott addressed council that he was not trying to dig up the pond they were digging rotten trees at edge and tractor slid into retention pond. He was not trying to hide anything. I am trying to do this the right way. Town Planner Mark Karet stated that you need to get a site plan to proceed with doing anything else on the property. Property Owner Chris Wilcott stated that all the water oaks are hollow and is has concerns for his lively hood and business.
